FREQUENCY OF YARD SALES No more than five (5) yard sale permits may be issued for any one address or resident or combination thereof during any calendar year, and no more than one (1) per calendar month. If multiple permits are issued to the same person at a different residence, or vice versa, the number of permits shall be counted collectively. HOURS OF OPERATION Yard sales shall be limited in time to no more than the daylight hours of four consecutive days. DISPLAY OF GOODS OFFERED FOR SALE Goods offered for sale or sold shall be displayed only on the property of the residence where a yard sale permit has been issued. Any unsold items shall be removed from public view at the end of daylight hour of the last day listed on the Yard Sale Permit. 	 (B) Yard sales must be conducted at the permit hold primary residence except as provided in (C) below.
